ONLINE PRIVACY POLICY AGREEMENT

Effective date: January 1, 2021

Grid 7 LLC DBA-Taekion (Taekion) values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Grid 7 LLC DBA-Taekion of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

We reserve the right to make changes to this Policy at any given time. If you want to make sure that you are up to date with the latest changes, we advise you to frequently visit this page. Grid 7 LLC DBA-Taekion may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. Notice to European Union Users

Grid 7 LLC DBA-Taekion's operations are located primarily in the United States. If you provide information to us, the information will be transferred out of the European Union (EU) and sent to the United States. (The adequacy decision on the EU-US Privacy became operational on August 1, 2016. This framework protects the fundamental rights of anyone in the EU whose personal data is transferred to the United States for commercial purposes. Your Rights as a Data Subject

Security
